LEGAL OPINION ON APPOINTMENT OF ASSISTANT PROFESSORS
(ON CONTRACT)

1. I am in receipt of letter dated 06.05.2019, No. IIITDM/RO/Court Cases/2019(ii), issued by the Registrar seeking legal opinion on the aforementioned appointment of Assistant Professors (on contract). From the letter, it is gathered that Institute has appointed certain Assistant Professors in the year of 2016 & 2017 initially for a period of 2 years. For such appointment, advertisement was issued on 23.04.2014, and the Faculty was appointed for a period of 2 years on contract basis, without any condition of extension in the offer letter. However, extension has been given to the said Faculty for a period of 1 year. It is also seen that the contractual appointments made have been given annual increments also. This procedure is incorrect. There are no Rules or regulations for making such appointments.
2. Contractual appointments are basically short term crisis management procedure. All appointments made against regular posts needs to be made by a Selection Committee in which advertisements for such posts are given wide publicity. The selection process must see that the eligible candidates fulfill the eligibility criteria of the posts concern. I have been given the circular issued by Government of India, Ministry of Human Resource Development Department of Higher Education for recruitment of Faculty under four-tier flexible

Faculty cadre. This circular in Clause 4 makes provision for appointment on contractual basis. The Faculty appointed on contractual basis are to be governed strictly as per their contractual appointment order. The extensions given are incorrect. In case, the Contractual Appointees are working against permanent posts then fresh advertisement be issued and a Selection Committee be constituted to scrutinize the appointments against such permanent posts. The practice of contractual appointment against permanent posts is incorrect. The contractual appointments can be made only for short term crisis management for recruitment of a Faculty.

3. In my opinion, extension which have been given be permitted to exhaust its time period. Further, fresh advertisement be made and a Selection Committee be constituted for appointment of Faculty against the permanent posts available in the Institution.

Further, Senate accepted proposal of relaxing the requirement of registering for maximum two forward courses for the students on Academic Break. Further, the Senate also relaxed the requirement of dropping the courses by academically deficient students. This is done on trial for one year and will be accessed at the end of a year.

The Senate also discussed the case of Masters' students on academic drop and as a special case permitted them to register for one additional course over and above the 16 credits thesis requirement and 02 credits of graduate seminar requirement so that they can complete their degree along with their batch mates.



All such students will be submitting following undertaking:

"I (name of the student) am aware of the rules related to academic deficiency and as a special case the Senate is permitting me to register with relaxed criteria. In case, I do not fulfill the requirements to come out of academic deficiency at the end of semester, my academic program will consider to be dropped automatically".

Masters' dissertation submission and evaluation

Head ECE informed about the methods being followed for evaluation and submission of dissertation works for Master's program. Revision in policy for Swayam course

Presently a student can register for maximum one Swayam course and the course is evaluated by internal faculty by conducting examination in the Institute. It is decided that for the Swayam courses, no internal evaluation will be made and the grades as allotted by the Swayam Governing Body (NPTEL for engineering) will be as it is mapped with the Institute grading and recorded in the grade sheet. It is decided that it will be the responsibility of the student to appear in the evaluation process of the Swayam course (quiz, assignment, examination, etc.) and submit the final grade certificate to Swayam Coordinator of the discipline. A framework will be formed for mapping the credit of the course and grades obtained in Swayam courses with the Institute credits and grades.

It is further decided that every student irrespective of his performance in the regular semester courses may register for the Swayam courses with prior approval of the discipline Swayam coordinator. Each discipline will have one discipline Swayam coordinator for the Swayam courses who will keep record of the students registered and will track records of the student's performance. The coordinator will submit the grades to the academic office at the end of semester.

These rules will be applicable with immediate effect.



Proposal for Introduction of PBI in VII Semester

Following is proposed:

1. A student will submit the PBI registration (both internal/ external) form to the discipline.
2. DUGC will review the application for the PBI and give its recommendation with a merit list.
3. Head of the discipline will grant approval for the PBI based on the merit of the application based on the recommendation of DUGC.
4. The students carrying out internal PBI has to opt for 4 credits of courses along with PBI in that semester. For external PBI the students need to earn 4 additional credits in previous semesters.
5. Maximum 20% of the batch strength will be allowed to opt for internal PBI. Rest of the students of that batch will go for the external PBI.
6. It is proposed to introduce this scheme starting from the current 3rd year batch i.e. 2017-2020.

Proposal for Masters' dissertation submission and evaluation

The following changes are proposed for the submission and evaluation of Masters' thesis:

- a. A student will carry out project/ thesis work during the third and fourth semester. This carries a total of 32 credits (16 credits being assigned in third semester and 16 credits during fourth semester). A student shall carry out the project/ thesis work under the supervision of a faculty member.
- b. A student may undertake thesis work internally or may undertake to execute the project/ thesis work in collaboration with an Industry, Research and Development Organization or another academic institution/University where sufficient facilities exist to carry out the project work.
- c. For the collaborative project/ research work, in addition to the Supervisor from the Discipline/ Programme, a joint Supervisor may be appointed from the Industry, a Research Laboratory or another University with the approval of the Dean Academic on recommendation of DPGC. The Joint Supervisor will be associated with the guidance and may also be associated with evaluation of the performance of the student. The internal Supervisor may, if felt necessary, visit the Industry, or the Research Laboratory or the University in connection with the project/ thesis of a student.
- d. For the purpose of assessment, the performance of a student in the project/ Dissertation work in the fourth (or final) semester will be evaluated. Performance in the dissertation for other semesters will remain same. The following is proposed:
 - (i) The student shall submit the dissertation report latest by last date of the dissertation submission (June 30 of that particular year) to the Head of the discipline through his supervisor. The head of the discipline will send the report to the external examiner for evaluation.
 - (ii) The student will have to appear for defense before a committee consisting of PGPC and one external examiner on the date specified by the Head of the Discipline.
 - (iii) The grades against dissertation work of 16 credits in fourth (or final) semester shall be assigned on the basis of grades (10-point) awarded in following components:

Grades Awarded by	Weightage in SPI
Dissertation supervisor	50%

Where, W1, W2 and W3 are equivalent grade point corresponding to the grade awarded in components as mentioned in the table1 above.

- e. A student has to have a satisfactory performance (minimum 40%) in each component separately to qualify for the degree.
- f. The thesis will be sent to the external examiner from a panel of experts approved by the Director submitted through Dean Academic. The panel will be suggested by the DPGC for examination. Such correspondence will be carried out at the level of Head of the Discipline.
- g. Defense examination will be held on or before the date fixed in the Academic Calendar. The external expert along with PGPC will conduct the defense examination.
- h. In the case a student is not able to submit the dissertation by the last date of submission, such students have to register for the next full semester and have to submit the dissertation by December 01 of that year.

Proposal for Special Ph.D. Programme for Persons Employed in Defense Establishments

There are five major defense establishments in Jabalpur: Vehicle Factory Jabalpur (VFJ), Ordnance Factory Khamaria (OFK) and Gun Carriage Factory (GCF), College of Materials and Management (CMM) and 506 Workshop apart from several Army units. These establishments have working professionals with vast experience. Request has been received from the professionals to carry out the Ph.D. from the Institute.

As they are in the vicinity of the Institute, it is proposed to start special part time Ph.D. programme especially for the working professionals employed in the defense establishments.

It is proposed that

- i. Such candidates will be recommended by their parent department and approved by the DPGC of the concerned discipline for the PhD admission.
- ii. Most of their work will be carrying out at their parent department only.
- iii. For such candidates residence requirement will be waived. Further, they will be given waiver for Communication English course and teaching credits but they need to fulfill all other requirements of Ph.D. programme.
- iv. The candidates will have a supervisor from the Institute and one external supervisor from the concerned establishment.
- v. A MoU will be signed with all establishment/unit for the purpose.

Change in the requirement for Ph.D. admission

Presently it is mandatory for the Ph.D. admissions that the applicant must have qualified GATE/CEED/(CSIR/UGC-JRF/NET) or equivalent examination conducted at National Level. However, as per CSIR/UGC a candidate is eligible for the fellowship only when he/she has qualified JRF. In view of the same, it is proposed to modify the rule as follows:

For receiving the assistantship during the Ph.D. programme

1. The applicant must have qualified GATE/CEED or
2. The candidate must have qualified CSIR/UGC-JRF

However, a candidate who has qualified CSIR/UGC-NET but does not qualify for CSIR/UGC-JRF, will be admitted without assistantship.

**Guidelines for the Sanction of Funds to carry out experimental work related to
Research/ Project by the Students**

Following guidelines are proposed for the sanction of funds to carry out experimental work related to research and project by the students:

1. Ceiling on the amount
 - I. For Ph.D. students:

A student can get upto Rs. 50,000/- in his/her programme for the experimental work. Requirement for the experiment will be evaluated and recommended by the RPC of the student and forwarded by the Head.
 - II. For Masters' students
A student can get upto Rs. 10,000/- in his/her programme for the experimental work. Requirement for the experiment will be evaluated and recommended by the PGPC of the student and forwarded by the Head.
 - III. For Undergraduate Students
For the research project or PBI during VII and VIII semesters, a student can get upto Rs. 5,000/- for the experimental work. Requirement for the experiment will be evaluated and recommended by DUGC and forwarded by the Head. For other projects such as 'course project' or 'optional project' or 'Design Project' or 'Design and fabrication project', the instructor incharge/ faculty mentor will take necessary approvals which will be forwarded by the Head.
2. Two or more students in a group may combine this fund to purchase an item or set of items required for their experimental work.
3. The sanction of fund will only be for the experimental purposes and not for the purchase of computer/ laptop/ computer peripherals.
4. The components/ equipment purchased will become part of the concerned discipline and will be entered in the stock register of the associated lab.

All such applications will be approved by the Director on the recommendation of the Dean Academic. The Director will have discretion power to allocate fund for the purpose.

Modifications in Merit cum Means Scholarship

Following modifications are proposed for the award of MCM scholarship

1. The scholarship will be extended to B.Des. students also.
2. Gross annual income limit (from all sources) of parent/guardian will be Rs 2,50,000/-.
3. Annual income limit of Rs 2,50,000/- and minimum CPI of 7.0 (for Open Category) and 6.5 (for SC/ST) will be the minimum eligibility criteria for MCM Scholarship. The final selection will be based only on the performance in the last two semesters with no weightage to Annual income.
4. First year students will be given MCM scholarship during first semester based on their inter-se merit in JEE.
5. The Tuition fee waiver to additional 10% students will be withdrawn.
6. The number of scholarship will be limited to 20% of batch strength in each discipline and will be reduced by 5% every year to limit it to 10% of the batch strength.

Opening remarks by the Chairman

The Chairman B&WC welcomed all the members. He added that the four buildings out of the prioritised projects, have been taken into use by the Institute and all the amount as demanded by CPWD has already been deposited, but the work of Narmada Residency – III is still going on by the CPWD. The CPWD is required to take due attention to complete, at the earliest, the balance works in the building.

B&WC/2019: 26.02

Confirmation of Minutes of 2019/1st meeting of the Building & Works Committee (25th meeting) held on May 09, 2019.

The minutes of the 25th meeting of the Building & Works Committee were circulated among the Members & Special Invitee present in the meeting. The Executive Engineer (Civil), JCD, CPWD, Jabalpur has communicated some comments on the MoM. The copy of the same is being attached as 'A'.

The committee recommended to incorporate the comments of the EE (C), JCD, CPWD, Jabalpur in MoM of 25th meeting of B&WC.

B&WC/2019: 26.03

To discuss the status of ongoing / pending works by the CPWD.

- A) It was observed by the committee that the progress of balance work in Narmada Residency – III is still unsatisfactory. The pending works in the building, Narmada Residency –III were discussed in detail. It was asked to the CPWD to provide to the contractor the necessary decisions, at the earliest, to complete the balance works. It was opined by the committee that so far as, it is concerned with stability of door chauhats at outer walls of flats, necessary strengthening may be done, by using hilti make fasteners. The committee made request to CPWD (Elect) to resolve, at the earliest, the issues related with Lifts in the building. It was ensured from CPWD side that all the pending works in the building shall be completed by next one and half month.
- B) The work related with services, for which the old tenders have been revived by the CPWD, were discussed at length. It was opined by the committee that the CI pipes already procured by the CPWD, for firefighting works may be utilized in buildings like PG Hostel (Ph-II), Hall of Residence-IV and Mess & Dining Hall etc., where Firefighting works are still lying pending. Further, the CPWD informed that the tenders for cabling works for street light have already called by them and the street light work would be completed very soon.
- C) The pending works by CPWD for rectification of works done earlier were discussed at length. The CPWD informed that they have issued notices to concern agencies for make rectification in water proofing work under the relevant guarantee bound. In

case of non-action by the agency they would call new tenders to make rectification work on the cost of original agency. It was further informed by the CPWD that the repair fallen false ceiling in LHTC building shall be done very soon. The strengthening of false ceiling, if required, shall be done subsequently.

B&WC/2019: 26.04	To discuss the issue related with installation of Solar Power Plant at the campus and to identify the suitable location in the campus to develop as a Solar Park.

The issue related with installation of Solar Power Plant at the Campus was discussed at length. The committee expressed its satisfaction for the efforts of the Institute on in this direction. 
