## Opening remarks by the Chairman

The Chairman welcomed all the members of the Board and congratulated Prof. Bhartendu Kumar Singh, Department of Physics, BHU University, Varanasi on becoming the Director of the Institute and hoped that he may complete his full term of 5 years in the said office. He expressed his confidence that although Prof. Singh is in a directorial debut, yet the Institute would make great progress in the years to come considering his rich experience in a vast organization like BHU Varanasi. The Chairman was pleased that the Institute has now come out of its embryonic stage and is now on the path of progress and will achieve great strides in the coming days.

The Chairman thanked Prof. P. N. Kondekar for completing his 18 months tenure as Acting Director and for being instrumental and getting proactively engaged in the progress of the Institute on all fronts despite limited authority and umpteen responsibilities.

than going for BOG imposed decisions. With regard to limit of withdrawal from IRG, it was left to the discretion of the Director to take a call.

BOG/49/2 Overview Report by the Director

At the outset, the Director thanked the Hon'ble Chairman and the Board members for attending the meeting. Subsequently, he gave a PPT presentation of the annual report of the Institute on the following key points:

- 1. Academic
- 2. Placement
- 3. Student Activity
- 4. Research, Publication, Projects and Patents
- 5. International cooperation

NIRF Ranking: A tabular presentation of NIRF ranking since 2016-2022 was presented before the Board by the Director, wherein concern was raised regarding slipping rank of the Institute during previous years. Some of the reasons cited were decrease in Teaching Learning and Resources alongwith decrease in research and professional practices. He emphasized that one of the key parameters amongst others whereby ranking could be substantially improved is by faculty recruitment.

Other key areas of the Institute wherein the Board was apprised were:

- Perception
- Research and Professional Practice
- Outreach and Inclusivity
- Academic- Current Strength
- Placement Status
- International Internship and PPO offer
- Student Activity/Student Achievement/Cultural Fest
- Publication, Projects and Patent and IPR Activity
- International Cooperation

The Chairman appreciated about the EL&ICT project of Prof. Aparajita Ojha, Principal Coordinator wherein a final sum of Rs. 9 crore were sanctioned for the same. It was informed by the Registrar that the amount was utilized for conducting various Faculty Development Programmes. The Director was asked to revert back with full facts and figures of the money utilized and spent till date.

The Chairman suggested that the alumni spread pan India and worldwide be contacted to get a feel of the modern times and industry so that new additions to the existing syllabus of the institute can be made accordingly in keeping with the contemporary times.

The Director recommended that as in other IITs across the country, the Computer Centre in-Charge should be of the rank of Professor and not Associate Professor. The Board agreed to the same.

(i) Legal opinion of Advocate Shri Ajay Pal Singh on the order of Hon'ble High Court in WP/4825/2023.

It was informed by the Registrar, that a WA has already been filed. One of the Board member opined that at the outset efforts should be made to resolve the issue at the Institute level, nonetheless, if a case is filed then it should be pursued till the Apex Court of the Land considering the Institute's interest. Board agreed and asked the Director to firstly have continuous communication with faculty to avoid litigation but inspite of that if the case is filed, then the Institute should appoint the best available lawyers to fight such cases and make an effective attempt to win the cases.

(ii) Request of Dr. Ayan Seal, Assistant Professor for relieving him to join IIITDM Kurnool

It was informed to the Board the Dr. Seal has rejoined back to the Institute.

(iii) Relieving order issued to Shri R. P. Dwivedi, Joint Registrar

The Registrar informed that relieving order has been issued to Shri R. P. Dwivedi, Joint Registrar in compliance to the order of the Hon'ble Court. The Board noted the same. Institute has preferred an appeal against the court order in this case.
