BOG/2010:02.01 Opening Remarks by the Chairman

Chairman welcomed the members and requested the Director to commence the meeting.

BOG/2010:02.02 Overview Report by the Director

The Director welcomed the members and introduced special invitees and the new member Professor Puneet Tandon with other members of the Board and presented the following overview report.

- Second Batch of Undergraduate Students Completed their Degree Requirement. 68 out of 74 students of the second batch of undergraduate students admitted in July-August 2006 completed their degree requirement in the month of July, 2010. Five post graduate students also completed the requirement of the degree of M. Tech. / M. Des. and three were on the verge of completing their thesis.
- o Raman Distinguished Lecture Series Inaugurated. Dr. Anil Kakodkar, Former Chairman, Atomic Energy Commission, an outstanding nuclear scientist and DAE-Homi Bhabha Chair Professor at BARC delivered the first Raman Distinguished Lecture on the topic 'Towards safe and secure energy future' on March 17, 2010 at PDPM IIITDM Jabalpur.
- o Special Lecture by Prof. Manindra Agrawal. Prof. Manindra Agrawal, a noted Computer Scientist from IIT Kanpur delivered a special lecture on NP ≠ P hypothesis on March 23, 2010 in the colloquium.
- Colloquium Started. From Semester II, 2009-10, regular colloquium has started on every Friday and fourteen members of the faculty and research staff have contributed in the colloquium.
- Student's Placement Status. 47 out of 68 qualifying students were placed with the efforts of Institute placement office. Special classes and group discussion sessions were held to enable students improve their communication and soft

skills. One student got placed overseas with Amada, Japan. Apart from this, many students obtained good scores in GATE and GRE and some of them could also get admissions in premier institutions. Chairman, BOG has been very kindly giving his guidance in the possible placement of students in PSUs for the next batch.

- Students' Activities. Students' activities gained momentum in the year 2009-10 since they were able to organize various events in their own campus. A good number of students organized and participated in intra and inter Institutional technical, sports and cultural activities. The annual sports festival *Gusto*, technical festival *Abhikalpan* and the cultural festival *Tarang* were well organized by the students with huge participation of students of other colleges from Jabalpur. Apart from this, students also participated in events organized by other prestigious institutes of the country and bagged many prizes in such competitions.
- Improved Lab Infrastructure. Lab infrastructure has now been improved with
 equipment in all the three disciplines. Some of the major equipment
 procured/installed for creation of advanced labs are cluster computers, server
 for biometric labs, high end systems for digital signal processing, CNC
 machines, injection molding machine, rapid prototyping machine, Infra red
 camera, SEM, XRD and AFM.
- Faculty. The year was successful in all aspects. (i) A significant number of faculty participated in international /national conferences /workshops and presented their papers. Five research/development/consultancy projects have also been sanctioned by funding agencies.
- IIIT Japan Collaboration. Some of the renowned experts from Japan visited the Institute. Among them were Professor Takashi Nanya, University of Tokyo, Professor Miura, National Institute of Informatics, Tokyo and Professor Iwatsuki of Tokyo Institute of Technology. They delivered course lectures and extended support in our teaching programme. Twelve other experts also visited the Institute for delivering lectures to contribute in our teaching programme. Three post graduate and twelve undergraduate students went for an exposure visit to Japan and seven went for summer internship during the summer vacation. These students were selected on the merit basis and the requirement of companies for interns. Four of the students have also got pre-placement offers based on their internship performance.
- Campus Infrastructure Development Activities. Following projects have been handed over to CPWD for construction. (i) Residential complexes -Narmada Residency II and III (total 110 flats) (ii) Security barrack. Work of Mess and Dining Hall has started with a capacity of accommodating 400 students simultaneously. Progress of construction of Triple Seated Hall of Residence 3 is satisfactory. In addition to this, following works are under design/tender stage (i) Lecture Hall and Tutorial Complex and (ii) Visitors' hostel (iii) Triple Seated Hall of Residence 4 (iv) boundary wall (v) road network and external electrification. The construction is likely to begin soon.



Members of the Board noted with satisfaction, the progress made by the Institute on various fronts.

The Board accorded Administrative Approval and Expenditure Sanction on the recommendations of Finance Committee for the work of construction of Triple Seated Hall of Residence renamed as Hall of Residence-4 with a Preliminary Estimate of Rs. 22,78,04,000 (Rs. Twenty two crores seventy eight lakhs and four thousand only) including 3% contingencies and 2.5 % Architect Fee with Service Tax on Fee as applicable. The work will be executed by CPWD.

(2) B&WC/2010:02.04 To consider the Preliminary Estimate for the work of Construction of Visitors Hostel

The Board accorded Administrative Approval and Expenditure Sanction on the recommendations of Finance Committee for the work of construction of Visitors Hostel with a Preliminary Estimate of Rs. 11,85,22,000(Rs. eleven crores eighty five lakhs and twenty two thousand only) including 3% contingencies and 5 % Architect Fee with Service Tax on Fee as applicable. The work will be executed by CPWD.

(3) B&WC/2010:02.05 To consider the Revised Preliminary Estimate for the work of Construction of Lecture Hall & Tutorial Complex.
