Subject: Resolution by circulation - Installation of 500 KW Grid Connected Roof Top Solar power plant at PDPM IIITDM Jabalpur Campus.

[The Principal Secretary, New and Renewable Energy Department, Govt. of Madhya Pradesh, has informed vide DO No. 311/60, Bhopal, dated 11/10/18, that the Institute has been selected for installation of roof top SPV power plant of 500 KW capacity as a part of "Group-C" which has various institutions of Central Govt./National importance with total capacity of 5.17MW. MPUVN, as Project manager invited tenders for solar plants on competitive basis after consolidating demands from various institutes of MP. It is further informed that for the project, the rate offered by M/s AMPSOLAR India Pvt. Ltd. New Delhi is Rs.1.67/KWh. The rate per unit offered is the lowest among other educational institutions of MP. Financial implication from the Institute's side would be only the cost of net meter supplied by MPEB. The same RESCO has been given the installation work of roof top SPV in other CFTIs (Annexure-I – List of CFTIs).

It is further suggested by Project Manager that for timely implementation, Power Purchase Agreement (PPA) may be signed at the earliest. The PPA proposed by MPUVN is enclosed for kind perusal and approval please].
