FC/2012:02:02 Overview Report by the Director

The main emphasis of the Institute during the Financial Year 2011-12 has been on building infrastructure to facilitate faculty and students by providing them all possible amenities. For the last two financial years the Institute has shown good fund utilization performance.

The Ministry of HRD has sanctioned Rs. 55.00 Crores as Plan Grant for the Financial Year 2011-12, but by the end of financial year Institute received Grant of Rs. 40 Crores and remaining Grant of Rs. 15 Crores was received in F.Y. 2012-13. Institute has utilized Rs. 41.92 Crores for the F.Y. 2011-12 with payment liabilities of Rs. 2.17 Crores on account of equipment's, constructions etc. and deposit payable to CPWD of Rs. 15.00 Crores. Major expenditure has been incurred in construction of buildings of Rs. 2311 lakhs including Civil deposit to CPWD (Rs. 1623 Lakhs), Lab Equipment of Rs. 115 lakhs, Office Equipment of Rs. 17.14 Lakhs, Furniture of Rs. 37.43 lakhs, Computer peripherals and software of Rs. 169.98 lakhs and Books and e-Journals of Rs. 137.31 lakhs. The remaining amount of Rs. 15 Crores received after 31 March 2012 has been paid to CPWD for construction work for the Financial Year 2011-12 during the Financial Year 2012-13.

The annual audit of the Institute for the financial year 2011-12 was completed successfully by Principal Auditor General (M.P.), Gwalior and audit report of the Institute is awaited.

The Chairman welcomed the members and apprised the committee that the Hon'ble Human Resource Development Minister has desired that the Institute should complete all major construction projects by March 2013 by expediting the ongoing construction works.

FC/2012 :01.02	Overview Report by the Director	

The Director informed the Committee about the budget allotment of Rs. 4000.00 lakhs as Plan Grant-in-Aid by MHRD against the Board's recommendation of Rs. 5000.00 lakhs for the F.Y 2011-12 as Budget Estimates. In view of the growing needs of expenditure with better pace of construction activities in the

campus, the Institute proposed a revision in the budget to 6522.19 lakhs. Members suggested to have a discussion with officials in the MHRD (with JS (T) and Director (Finance)) for a justification of fund requirement and authorized the Chairman to take a decision on the revised budget.

A proposal of construction projects worth 9086.7 lakhs approximately was recommended to the Finance Committee by the Building and Works Committee for developing infrastructure at the Institute campus. At this stage the members suggested to have an overall assessment of the fund requirement for creation of basic infrastructure at the Institute Campus in the current and next financial year in view of the hon'ble HRM's directives to complete the construction work by March 2013. Some of the members also suggested that the requirement should be viewed from a long term perspective with the possibility of accommodating 7000-8000 students. Accordingly vertical expansion should be planned to save the land for future expansion.

After deliberations on the proposed construction projects which were presented by the Director of the Institute, the Finance Committee recommended the following projects to the Board of Governors for administrative approval and expenditure sanction.

- B&WC/2012:01:03: Construction of Hall of Residence 7 (PG Hostel (Phase-2) capacity 404 single seated) for an amount of Rs. 2369 lakhs.
- (2) B&WC/2012:01:04: Construction of Administrative Block for an amount of Rs. 1454.14 lakhs.
- (3) B&WC/2012:01:05: Construction of Student Activity Centre-I for an amount of Rs. 1816.3 lakhs.
- (4) B&WC/2012:01:08: Construction of Hall of Residence 8 (Girls Hostel-1 Capacity 296) for an amount of Rs. 1512.06 lakhs.
- (5) B&WC/2012:01:09: Construction of Rewa Residency-2A (72 no of 2bed room apartments for staff) for an amount of Rs. 1440.00 lakhs.
- (6) B&WC/2012:01:10: Construction of Primary Health Centre for an amount of Rs. 495.2 lakhs.

The Finance Committee also suggested that the architects be advised to make a walk- through-model of the buildings for a detailed understanding of the various Institute buildings under construction. The same may be presented in the next meeting of the Finance Committee.

Opening Remarks by the Chairperson, B&WC

Chairperson and the Director of the Institute Prof. Aparajita Ojha welcomed all the members. The Chairperson introduced the nominees of the members and special invitees with the other members of the Committee. She presented a brief overview of the Institute activity and plans for next six months and requested the secretary to proceed with the agenda items.

B&WC/2012:02:02

Confirmation of Minutes of 2012/1st meeting of the Building & Works Committee held on 07 January, 2012.

Minutes of the 2012/1st meeting of B&WC held on January 7, 2012 were confirmed.

B&WC/2012:02:03

To consider the Preliminary Estimate for the work of Construction of Hall of Residence-2 at PDPM IIITDM, Jabalpur.

The committee discussed at length the Preliminary Estimate (PE) and Preliminary Drawings of the work as provided by the consultant M/s Convince Ray & Choudhary. The members expressed their satisfaction with the preliminary drawings but observed that the value of estimate is on a higher side. The vetted estimate could not be received from the CPWD. Sh. S.B. Pandey EE(C) CPWD pointed out, that some of the components taken in PE may be omitted as they are covered within the basic cost. He stated that there is a possibility of reduction in cost. After deliberations the members opined to consider this estimate after getting it vetted from the CPWD.

The committee deferred this item to next B&WC meeting.

B&WC/2012:02:04

To consider the Revised Preliminary Estimate for the work of Construction of Triple Seated Hall of Residence-1 (renamed as Hall of Residence-3) at PDPM – IIITDM, Jabalpur.

The B&WC discussed at length the Revised Preliminary Estimate (RPE). The letter received from the CE(CZ)CPWD, Bhopal regarding the verification of cost index 122% as on 01.01.2010 and the vetted RPE by Sh S.B. Pandey, EE(C), CPWD Bhopal were deliberated. The members also observed the need of RPE so as to settle the final bills for the work. The B&WC approved the RPE for an amount of Rs.2159.23 lacs (Rupees two thousand one thousand fifty nine point two three lacs) with 22% cost index, 1% quality assurance, 1% labour cess, 5% architect fee and 3% contingency.

The Committee recommends to the Finance Committee to consider the above proposal for onward recommendation to the BOG for Administrative Approval and Expenditure Sanction.

To consider the report of the reconciliation committee constituted to settle the disputes of M/s Kanvinde Rai & Chowdhury.

The report of reconciliation committee was discussed in detail. The Director and the Chairperson, informed the members that this issue had become a major constraint in the progress of development works in the campus. She appreciated the efforts of the Dean, Planning & Development in resolving the issue by creating a mutual consensus among all the three consultants so that any payment being made to M/s KRC against its claims could not cause any repetition of payment of consultancy charges for any particular construction project. The members deliberated the report of reconciliation committee and recommended it for final approval.

The Committee recommends the resolution to the Finance Committee to consider the above proposal for onward recommendation to the BOG for final approval.

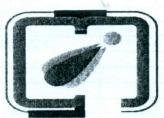

SCHEDULE - 24 SIGNIFICANT ACCOUNTING POLICIES

A] ACCOUNTING CONVENTION

The financial statements are prepared on the basis of historical cost convention, unless otherwise stated and on the accrual method of accounting as per the Common Format of Accounting prescribed by Ministry of Human Resource Development (MHRD) for all Central Autonomous Bodies.

The account has been maintained on accrual system.

B] INVENTORY VALUATION

Expenditure on purchase of Stationery, Chemicals, Glassware, Publications, Building Materials and Other stores is accounted as revenue expenditure. The closing stocks of these at the end of the financial year are ascertained and inventory accounts set up be credited to the respective expenditure heads.

C] INVESTMENTS

There are no investments other than Bank Fixed Deposits, which are valued at cost only. No brokerage or other expenses have been incurred in making such investments.

D] FIXED ASSETS AND DEPRECIATION

- 1. Fixed assets are stated at cost of acquisition including inward freight, duties and taxes and incidental and direct expenses related to acquisition, installation and commissioning.
- 2. Electronic Journals (E-Journals) are separated from Library Books in view of the limited benefit that could be derived from the on-line access provided. Though E-Journal are not in a form, they are capitalized in the view of the magnitude of expenditure and the benefits derived in terms of perpetual knowledge acquired by the Academic and Research Staff. Deprecation is provided in respect of E-Journals at a higher rate of 40% as against depreciation of 10% provided in respect of Library Books.
- 3. Expenditure on acquisition of software has been separated from Computers and peripherals, as apart from being intangible assets, the rate of obsolescence in respect of these is very high. Depreciation is provided in respect of software at a higher rate of 40% as against depreciation of 20% provided in respect of Computers and Peripherals.

F] <u>REVENUE RECOGNITION</u>

- 1. Fees from Students (except Tuition Fees), Sales of Admission Forms and Interest on Saving Bank Account are accounted on cash basis. Tuition Fees collected separately for each semester is accounted on accrual basis.
- 2. Income from Land, Buildings and Other Property and Interest on Investments are accounted on accrual basis.

G] GOVERNMENT GRANTS/ SUBSIDIES

- 1. Government grants/ subsidy are accounted on realization basis.
- 2. Government Grants are accounted on realization basis. However, where a sanction for release of grant pertaining to the financial year is received before 31st March and the grant is actually received through cheques dated 31st March in the next financial year, the grant is accounted on accrual basis and an equal amount is shown as recoverable from the Grantor.

3. To the extent utilized towards capital expenditure, (on accrual basis) Government grants are transferred to the Capital Fund.

4. Government grants for meeting Revenue Expenditure (on accrued basis) are treated, to the extent utilized, as Income of the year in which they are realized.

H] FOREIGN CURRENCY TRANASCTIONS

Transactions denominated in foreign currency are accounted at the exchange rate prevailing at the date of the transaction.

To the extent not immediately required for expenditure, the amounts available against such funds are invested in approved Securities & Bonds or deposited for fixed term with Banks, leaving the balance in Saving Bank Accounts.

Interest received, interest accrued and due and interest accrued but not due on such investments are added to the respective funds and treated as Income of the Institute.

Sponsored Projects

In respect of ongoing Sponsored Projects, the amounts received from sponsors are credited to the head "Current Liabilities and Provisions- Current Liabilities – Other Liabilities – Receipts against ongoing sponsored projects." As and when expenditure is incurred / advances are paid against such projects, or the concerned project account is debited with allocated overhead charges / Institutional charges the liability account is debited. Overhead charges / Institutional charges recovered from projects are credited to the Corpus Fund in accordance with decision of the Executive Council of the Institute... Debit balances, if any, against individual projects, are shown under Current Assets, Loans & Advances and not set off against Credit balances in other projects.

The Institute itself also awards Fellowships and Scholarships, which are accounted as Academic expenses of the Institute.

J] RETIREMENT BENEFITS

- 1. The Institute is covered under NPS (New Pension Scheme) rules as frame by Govt. of India.
- 2. Due to Non availability of proper detailed guideline from Government of India, no Provision for retirement benefits could be made.

B] GRANT RECEIVED/RECEIVABLE.

- Rs 55 Crore (Rs 12 Crore for General Expenses and Rs 43 Crore for Creation of Capital Assets) was sanctioned as Grant- in- Aid during the F.Y. 2011-12 by the Ministry of MHRD of Govt. of India. Out of the total sanctioned Grant of Rs 55 Crore, only Rs 40 Crore was actually received during the financial year 2011-12 and utilised as per the sanction terms. And, the remaining amount of Rs 15 Crore has been shown as receivable under the schedule-11 of Current Assets.
- Amount deposited to (CPWD) during the financial year towards capital work aggregating of Rs. 16,23,00,000/- being utilized for the purpose of utilization of Grant.
- 3. Rs 10,57,812/- was the grant receivable in the FY 2010-11 towards under the Central Sector Scholarship Scheme of Top Class education for SC Student. Out of this receivable grant Rs 653543/- was received in FY 2011-12 and still Rs 404269/- is receivable and shown under current assets.
- 4. Utilization of Grant for General, Scheduled Castes and Scheduled Tribe Category has been divided in the same proportion as grant in aid received and shown accordingly in Utilization Certificates.

1. Proposal for increasing the Income limit of parents from 2.00 lakh to 4.50 lakh for eligibility to Merit- cum -Means (MCM) Scholarship to the students :-

At present the limit of parent's income is Rs. 2.00 lakhs per annum as eligibility criteria for MCM scholarship to the Institute's students. The same eligibility was there for Top class education for SC/ST students, given by the Ministry of Social Justice and the Ministry of Tribal Affairs, Govt of India . Both the Ministries have extended the income limit upto Rs. 4.50 lakhs per annum (copy of letter is enclosed as <u>Annexure-1</u>).

Finance Committee is requested to consider the proposal for MCM Scholarships for the students of the Institute inline with the Upper limit for Central Sector Scholarship and recommend to the BOG for approval.

> Revision in the Central Sector Scholarship Scheme of "Top Class Subject: Education for SC students."

Sir

The Government of India has been implementing the Central Sector Scholarship Scheme of "Top Class Education for SC students" since 2007(copy enclosed). It aims at recognizing and promoting quality education amongst students belonging to SCs, by providing full financial support. The scheme covers SC students for pusuing studies beyond 12th class. Under this Scheme the students who get admission in the Institutions notified by this Ministry are eligible to get financial support as scholarship for covering four items namely

- full tuition fee and non refundable charges (i)
- living expenses @ Rs.2220/- per month (ii)
- book and stationery @ Rs.3000/- per annum and (iii)
- a latest computer with accessories like UPS, Printer, Multimedia limited (iv)Rs.45000/- required for pursuing their higher study.

The scheme has now been revised w.e.f. the selection year 2012-13. The annual 2. family income ceiling from the selection year 2012-13 has been revised upward from existing Rs.2.00 lakh to Rs.4.50 lakh subject to the condition that if for the last available slot in an institution, there are more than one students with equal marks, preference may be given to the student with the lowest parental income.

The existing para 3.2 of the Scheme has thus been revised as follows: 3.

existing Scheme	Revised Para 3.2 (Applicable w.e.f. selection year 2012-13)	
The total family income of the student from all sources should not exceed Rs.2.00 lakh per annum.	The ceiling of total family income from all sources under the Scheme is Rs.4.50 lakh and the general selection criteria among the eligible candidates of any institution must be the merit. However, if for the last available slot in an institution, there are more than one students with equal marks, preference may be given to the student with the lowest parental income.	

4. Accordingly students who have secured admission in the notified institutions according to the norms prescribed by the respective institutions are eligible for the scholarship under the scheme subject to the condition that the total family income of the students from all sources should not exceed Rs.4.50 lakh per annum as stipulated in para 2 above.

5. It is requested to send the proposals for Scholarship in 2012-13 in the light of the above revision of the Scheme so as to reach the undersigned by 31st May 2012. The proposal for renewal of the scholarship sanctioned in the past may also be forwarded immediately.
