Dr. Kota Harinarayana, the Chairman of BOG/FC, welcomed all the members and Board members as special invitees. On behalf of the Finance Committee, he expressed his sincere thanks to the outgoing members for their noteworthy contribution.

The Chairman laid emphasis on raising the corpus by way of industry oriented projects, sponsored research projects and consultancy. He also expressed the need to strengthen IIITDMJ-Japan relationship through research collaboration, students and faculty exchange programmes, particularly in the field of manufacturing.

Members also deliberated on increasing the internal income by enhancing the tuition fee by making it at par with other institutions of national importance. It was informed to the members that the Plan Grant-in- Aid from MHRD was revised from 75.00 Crores to 62.00 Crores. However, in case some of the institutes are not able to utilize their plan grant, the same may be diverted in the last quarter. It was advised to follow up with MHRD officials regarding allocation of further grant in the current financial year. In addition to ongoing construction projects the Chairman suggested starting the work on some of the important construction projects and seek funds from the MHRD, GOI in the current/ next financial year.

FC/24/2	Overview Report by the Director	

The Director presented a brief profile of the Institute and the following facts and figures.

- (i) Budget and Expenditure Progress The Institute was allocated an amount of Rs. 7500.00 lakhs under Plan Grant by the MHRD for the financial year 2014-15. The Ministry has released Rs. 5709.62 lakhs till 31/12/2014 and Rs. 560.38 lakhs was unspent balance as on 1/4/2014. A total of Rs. 6270.00 lakhs was available out of which Institute has utilized a total of Rs. 6155.47 lakhs (which includes Salary 627.41 lakhs, General Expenditure Rs. 887.97 lakhs and Capital Expenditure-Rs. 4640.09 lakhs). The demand for releasing the remaining grant has already been made and funds are awaited from the Ministry.
- (ii) **Expenditure Progress under Capital head** -Out of the total capital expenditure of 4640.09 lakhs, the major expenditure has been incurred as given below.
  - a. Deposit with CPWD Rs. 4380.00 lakhs (This includes committed expenditure of Rs. 1500.00 lakhs under various construction projects)
  - b. Building and Works at Institute level 13.92 lakhs
  - c. Deposit with DGS&D Rs. 62.95 lakhs (Desktops)
  - d. Furniture & Fixtures Rs. 51.32 lakhs
  - e. Equipment Rs. 37.53 lakhs
  - f. Other expenses like online journals, books, computer software/hardware etc.
- (iii) **Expenditure Progress under General Head** Out of the total General Expenditure of Rs. 887.97 lakhs, the Institute has incurred expenditure as follows.

- a. New Pension Scheme Rs. 52.66 lakhs
- b. Professional Development Allowance Rs. 24.12 lakhs
- c. Manpower Outsourcing (Manpower and Security Services) Rs. 237.12 lakhs
- d. Assistantship and Scholarship Rs. 190.18 lakhs
- e. Students Support 18.55 lakhs.
- f. Electricity Charges 138.03 lakhs
- g. Honorarium Rs. 24.45 lakhs
- h. Internet and leased line Rs. 18.28 lakhs
- i. Repair & Maintenance Rs. 9.72 lakhs
- j Travelling and Conveyance Rs. 19.56 lakhs.
- k. Others Rs. 155.30 lakhs (includes Transport Service, Health, Professional Charges, LTC etc.)
