Subject- Kind appeal for reconsideration of extreme and severe decision of my termination and permission for continuation of my PhD program.

Reference- Letter No. IITDMJ/Reg./2014/09/1062 received by me conveying decision of my termination from PhD program (attached as *annexure 1*).

Respected Chairman BOG Sir,

I, Sunil Pandey, joined the institute on July 2012 as a PhD student under the supervision of Dr. Jawar Singh and completed almost two years of PhD program in June 2014.

I hereby make an appeal to kindly review the decision of my termination from the PhD program, as I am on the verge of completion of PhD program and was planning to give second progress seminar in the last semester.

I wish to submit the following for your kind perusal –

I was terminated on the charge of academic dishonesty for copying some content from a paper with the title- “A New Technique for Bandwidth Enhancement of Low Voltage Current Mirror” (attached as *annexure 2*).

Whereas, my published paper with the title is given below-

“A Wideband LNA design based on Body Bias suitable for Low Voltage and Low Power Application” (attached as *annexure 3*).

I want to highlight some major technical differences between both paper as described below:

- As the similarity in both the papers content is very minor and not up to a severe level. These basic equations and minor content are also available in standard papers [1], [2], [3] (attached as *annexure 4*). The idea and technique used in both the paper is totally different.
- There is no similarity between these two topics because current mirror is used for analog signal processing (MHz bandwidth), while, low noise amplifier (LNA) is used for RFICs and front end receivers (especially for GHz application). Hence, analysis provided in my paper is totally different from the complaining author paper, and related to only LNA which is my research area.

- We have used forward body bias technique (cited as [26] in our paper) for LNA design, where main focus were figure-of-merit (FOM) improvement of LNA in terms of power gain (S_{21}) and noise figure (NF), which can be clearly understood by equations (26) and (27) in our paper. These are two important parameters for making better LNA in terms of FOMs, whereas, The complaining author paper is based on reverse-body-bias (RBB) technique for bandwidth improvement of current mirror circuits, it makes a clear difference between both the papers.
- There are several standard research papers [4]-[8] are available which uses body bias technique only for LNA design. The reference [4], has also been referred in our published paper as [26] (attached as *annexure 5*).
- The RBB technique makes a trade-off between gain and power consumption when operating on low voltage conditions, while, FBB technique is just reverse of RBB technique and solves this trade-off. My paper based on FBB technique has also been published in IET Journals (**SCI Indexed**).
- Both techniques are old and exist in standard literature. The basic difference between both techniques is described below.
 - a) FBB technique is a renowned technique for low voltage applications. In case of FBB technique, the threshold voltage of NMOS device decreases and drain current increases, this can be easily understood by standard threshold voltage equation given below.

$$V_T = V_{TO} + \gamma(\sqrt{2\phi_F - V_{BS}} - \sqrt{2\phi_F})$$
 - b) On the other hand, in case of RBB, the threshold voltages of NMOS device increases and drain current decreases which makes a clear difference and changes the whole physics between both techniques.

Regarding my career, I also want to add some major points:

- As a PhD research scholar, I have successfully completed my **course work, comprehensive exam** and one **progressive seminar in two years**. My **CGPA** after the 4th semester is **9.1**. In first progress seminar, “**A**” grade is given by the research committee members (attached as *annexure 6*). Also, I have successfully completed first teaching credit in 4th semester with good feedback.
- I have represented IIITDM at the **29th M.P. young scientist congress** held at Vigyan Bhawan, Bhopal during Feb.28-March 01, 2014, and received “**Young Scientist Research Fellowship award**” from **M.P Govt.** including an award of International travel grant of “Rs. 40000” for presenting research paper abroad (attached as *annexure 7*).
- Since more than two years, I am doing hard work for the PhD thesis work and published two reputed **SCI indexed** journal papers and **five top** notch international conference papers, while, my three other journal papers are under review in **SCI indexed** Journals (the detail of publications is attached as *annexure 8*).
- My supervisor has acknowledged the hard work; I have done in my research and recommended to forgive me looking into my broad career ahead (attached as *annexure 9*).

- As a researcher, the complaining author only wanted that the author must be given a chance to improve and not to repeat this in the future (attached as **annexure 10**).
- As per PG manual clause 9.3.3 (updated on June 4, 2014), “A warning letter should be sent to the student and her/his parent guardian and the case is recorded on the file of the student”. But, in my case the decision is of termination without giving any warning letter (attached as **annexure 11**).
- Since, at that time it was the beginning of my research career. I was not quite aware about the sensibility and importance of citations. I have realized the mistake and apologized for that. However, I promise that in the future I will always abide by all the principles, rules and regulations of the institute. As, I could not be admitted in the college in fifth semester because of this case and even sixth semester already has been started.

Therefore, it is a kind appeal to the Chairman BOG sir to reconsider the extreme decision of my termination and allow me for continuation of my PhD program from the current session, so that, more damage to my career may be prevented.

In this 2nd attempt exam, I scored 43 marks in Analytical Methods in Engg. & copy of Analytical Methods in Engg. scrutinised along with Dr. Sujay Mukherjee. Scope of marks existed in every answer while seeing copies on 09-12-2014 in Academic office; but the instructor is repeatedly saying that this exam is going to be cancelled anyway. But Chairperson-Senate cancelled the comprehensive exam of Siddhartha Roll. no. 1310360, conducted on 29-9-2014 & on 19-11-2014 as it was conducted without prior approval of Chairperson-Senate. vide letter No. 111TDMJ/Dr (Acad.)/2014/12/2419/December 09, 2014 along with the request to Dr. M. Anandnath, Assistant-Professor (Mechanical Engineering) to conduct the comprehensive exam afresh of Siddhartha Roll. no. 1310360, PhD (ME) student.

Then fresh comprehensive exam held on 4/2/15 (of FME 617- Finite Element Methods in Mechanical Engg.) & on 5/2/15 (of Analytical Methods in Engineering, ~~ME 640~~), & Presentation cum Viva-Voce on 09-02-2015 and results provided by Dr. M. Anandnath, Asst. Prof (ME) on 11-03-2015 in which I passed in ME-640 Analytical Methods in Mechanical Engg. and failed in ME-617 (FEM) & Presentation cum Viva-Voce (oral exam) too failed. Photocopies of ME-617 seen along with the Instructor, Dr. M. S. Anand (Asst. Prof (ME)) with the scope of increase in marks existed; but the instructor informed me for rechecking by other faculty while scrutinising it. ~~Siddhartha Roll. no. 1310360~~

But Dr. V.K. Gupta, Dean-(Academics), told me that there is no provision for re-sitting at IIITDM-Jabalpur.

Noted on second-attempt of exams held on 10-04-2015 of ME-617 (FEN) and on 23-04-2015 of Presentation, cum Viva-Voce held; & then Deputy Registrar-(Academics), issued me Termination from Academic Programme letter on 07-05-2015, vide no. IIITDMJ/DR(Acad.)/2015/05/3199 dated May 7, 2015 and Revised Termination from Academic Programme letter on IIITDMJ/DR(Acad.)/2015/05/3200 dated May 8, 2015.
