Senate/2012-13/SPECIAL.2	Request of Ms. Anamika Verma (2009149) for permitting her to register for three courses in SummerTerm 2013

Dean Academic briefed the members of the Senate regarding the case of Ms. Anamika Verma. He presented the following facts before the members –

1. Ms. Anamika Verma was admitted to the B. Tech. (ECE) programme of the Institute, following the orders of Hon'ble High Court of Andhra Pradesh from the second semester, 2009-10 to the Central Counselling Board.
2. She applied for consideration of credits earned at NIT Raipur in her first semester. The Senate in its meeting (**Senate/2009-10/1.10**) did not consider including the weightage of courses successfully completed by her at NIT Raipur, due to difference in the course contents. (Annexure I contains extract of the decision of Senate regarding this).
3. Her academic performance has been satisfactory throughout her programme. However, she has not been able to score ≥ 8.0 CPI to become eligible for taking an overload, as per Section 3.2.6 of the UG Manual (Manual of Procedures and Guidelines for the Bachelors of Technology Programme).
4. She had requested to allow her to register for three courses during PBI in the academic session 2011-12, but the Senate in its meetings (**Senate/2010-11/2.06 and Senate/2011-12/3.08.4**) did not consider her request as she did not fulfill the criteria for overload as specified in UG manual (CPI ≥ 8.0) (Annexure II contains extract of the decision of the Senate regarding this).
5. She was permitted to clear her backlogs in the Summer Term 2010, 2011 and also in Summer Term 2012. She has been given full opportunity to clear her backlogs within the specified period.
6. She filed a writ petition with the Hon'ble High court of Madhya Pradesh at Jabalpur. A copy of the petition made by the student to the Hon'ble High Court of MP was placed before the Senate. Hon'ble High court disposed of the petition on April 17, 2013 with the following directions:
 "Keeping in view the return filed by the respondents and the statutory provision as is indicated therein, respondents are directed to permit the petitioner to undertake the summer course with regard to two of the subjects, as may be permissible. With regard to the third subject, petitioner is granted liberty to represent to the competent authority of the respondent's institute and the competent authority after examining it in the light of the rules, if permissible, shall pass appropriate orders on the same within a period of 10 days"
7. She has been permitted to register in two courses during the Summer Term 2013. These courses are
 - a. NS102 Engineering Physics I and
 - b. MN201 Fundamentals of Manufacturing Processes.



8. She has now represented to the Chairperson Senate to allow her to register for three courses in the summer term, 2013 to enable her to complete the B. Tech. programme along with her batch-mates. Her application is in continuation to the directions of the Hon'ble High court of Madhya Pradesh dated 17/04/2013 on her writ petition no. 3253/2013.

As per the directions of the Hon'ble High Court, her case was examined in the light of the rules to decide if she could be permitted to register in the third course. A copy of the petition made by the student to the Hon'ble High Court of MP was placed before the Senate. Each member also expressed his opinion on the case. Dean academic also apprised the Senate with the views received by e-mails of the following members –

Members also discussed her case from all the angles and with full sympathy. One member raised a query through email, if she has already earned the minimum credits to qualify for the B. Tech. degree. Dean, Academic informed the members that not only the minimum credits are required for completion of the degree requirement; one is also required to clear all the courses of the curriculum (Section 8.2.1 of UG Manual).

After deliberations Senate by majority resolved the following –


