After the initial welcome remarks by the Chairperson, Senate, the agenda items were taken up one by one.

The following overview report was presented by the Director:

1. Prof. S. V. Raghavan is nominated by the MHRD as the Chairman of the Board of Governors of the Institute on October 7, 2011 for a period of three years. Professor S. V. Raghavan is a Professor at the Department of Computer Science and Engineering, IIT Madras and is currently appointed as the Scientific Secretary to Principal Scientific Advisor to Govt. of India. Professor S. V. Raghavan has made significant contributions to the creation of the Education and Research Network in India. He is the chief architect of National Knowledge Network project of Govt. of India. He was the founder of ERNET and the Principal Investigator of the Programme at IIT Madras. His areas of research include Performance Evaluation, Information Security, High Performance Computing and Networks, Protocol Software Engineering, Multimedia and Network Design.

3. Students placement and achievements – Till date 34 placement offers have been made by Capital IQ, TCS and Avantha Power. TCIL, BEL, Infotech, Impetus Technologies, HCL Info systems, Samsung and Whirlybird Electronics have given their consent to come for campus placement in months to come, as informed by the placement cell.

#### Achievements –

Abhinav Suryavanshi was awarded Project Based Internship at Canon, Japan and has earned a pre-placement offer from the Company. Impressed with his performance, Canon has floated two project based internships this year.

Ankit Kudeshia (B. Tech 2006 batch) has been selected directly after B.Tech. for Ph.D. programme at IIT Kanpur after a very long period.

Yukti Suri (B. Tech. 2006 batch) and Saurabh Jain ( B. Tech. 2005 batch) have been recently selected for Erasmus Mundus Scholarship of European Countries.

Nitin Sharma (B. Tech. 2006 batch) is one of the 33 recipients of MEXT scholarship, Japan selected by MHRD.

Vineet Singh (B. Tech. 2006 batch) has joined for Ph.D. with Prof. Rajeev Gupta senior most professors of Computer Science and Engineering, at University of California.

Senate/2011-12/1.03	Report of the UGCS and PGCS

The Convener UGCS and PGCS presented the following Report on Academic Affairs:

Total 255 students were admitted through CCB Counselling (AIEEE-2011) in B.Tech. programme and 48 students were admitted in PG programmes (M.Tech /M.Des./Ph.D.) for the session 2011-12. The classes began on August 03, 2011 after the orientation programme held on August 02, 2011. Further, 37 more students were admitted in PG programmes for the winter session starting from January 2012. The admission process for PG programme for the winter session 2012 was started from October 7, 2011 and completed on December 28, 2011.

The Institute had introduced a component of Project-Based Internship of 25 weeks duration (mostly on some turnkey projects) starting from May 2011 as a part of the curriculum for the

Under Graduate students in all the Disciplines of Engineering at PDPM IIITDMJ. Under the internship, the students worked for about 25 weeks at various organizations/R&D labs in the country and also with the faculty members of PDPM IIITDM Jabalpur. The research works of some of our students are published/under review in some reputed journals and conference proceedings. Some students have given applications for review of their PBI grades.

At this point one of the members asked if the grades have been submitted for PBI. The Coordinator Academic Affairs informed the members that grades have been submitted and results have also been declared. However, some of the students have placed their application for review of PBI grades. The Chairperson, Senate informed the members that the Internship Board is looking into the matter and have decided to reevaluate the grades of applicants. The decision taken on this matter will be reported to the Senate for ratification.

One of the members suggested that the students be advised to acknowledge the work in the manuscript as work done under the PBI programme, for a wider publicity of the initiatives of the Institute to introduce PBI in the undergraduate curriculum. The Senate approved the suggestion. Some members suggested to have a student feedback on PBI experience of students (what worked, what did not work, etc.) as this is the first time it is introduced. A few students may be selected to present their experience and report before the Senate in a subsequent meeting.

Convener, UGCS informed the house that students' feedback exercise has been completed and students were satisfied with their experience of PBI. He informed that some students have suggested that it should be in the 8<sup>th</sup> Semester and the need for NPTEL course may be dropped. Senate discussed the point and decided to continue with the present model of PBI in VII Semester and NPTEL course with PBI. One of the members informed that adoption of NPTEL course was appreciated in one of the national level meeting of NMEICT. He suggested that students may be educated about the importance of NPTEL course.

**Counselling Report:**

Head, counselling services informed that a Psychologist is appointed on contract basis and she is visiting institute alternate day. The Head, counselling services informed that the academically weak students are hesitant to come forward and discuss their difficulties/problems and there is a general hesitation for extra classes. He informed that first semester students felt problems as they are suddenly exposed to this college environment and they have problems related to language and home sickness. He suggested that we can have slow pace of study for first year students, especially for academically weak students. He also informed that that two students of second year had gone missing with one losing his life due to a train accident at Kota. The Senate paid condolences on the death of Mr. Manish Chauhan. The Chairperson informed the members that a condolence message on behalf of the Senate was communicated to the bereaved family.

The Senate approved to extend the eligibility for M. Des programme from CEED to CEED or GATE qualified candidates.

Senate/2011-12/1.07	Evaluation process of PBI.

The Coordinator Academic Affairs presented a report on PBI and discussed about the problems in normalization of PBI marks awarded by external and internal guides to different groups. Based on the experience of running PBI, he also proposed a refinement in the evaluation process of PBI. The proposal was deliberated in the Senate. Members suggested simplifying the process especially for external examiners who may not be acquainted with the grading system of the Institute. One of the members suggested sending a covering letter to external guides which educates them about the expected work from students and grading pattern in terms of excellent, good, average and below average. After discussion, following amendments in the grading system were decided for implementation in future.

1. Each PBI will fall under one of the groups - ECE, ME, CSE and Interdisciplinary depending on the topic of the PBI. The IB will classify the PBI group before the mid semester evaluation. For end semester evaluation, four committees will be constituted by IB after the mid semester evaluation within a week. The PBI guide of a student will not be a member of the evaluation committee. In case a student's PBI falls under a group which is going to be evaluated by a committee having his PBI guide, the guide will be replaced by another faculty member/ external expert.
2. Students will be required to submit a copy of the mid semester PBI Report to each member of the evaluation committee within a week from the date of constitution of evaluation committees.
3. There will be four evaluations during the entire PBI period, first interim, mid semester, second interim and end semester. The guides will award interim grades after each evaluation and interim grading will be as follows:

Excellent (A), Good (B), Average(C), Satisfactory (D), Unsatisfactory (F)

4. The final grading will be awarded by the evaluation committees and will be duly forwarded by the IB to the Academic Office. The Chairman, IB will be responsible for submission of the grades to the academic office.
5. The evaluation committees will evaluate the projects based on the presentation made by the students and final project report, which should be made available to them at least one week before the end semester evaluation. The students will be required to submit two hard copies of the project report in the academic office with softcopies to each of the member of evaluation committee.
6. After evaluation of the project, the committee will review the grades submitted by the PBI guide and will award the grade in the end semester evaluation in congruence to the final evaluation. Accordingly, evaluation committee will review the grades and will award either one grade higher or one grade lower to the students based on the average grade obtained by the student in the three previous evaluations. The grades will be awarded as per the following guideline.

A+ or A for average grade A

B+ or B for average grade B

C+ or C for average grade C

D+ or D for average grade D

No change in grade for average grade F

However, grades may be lowered in exceptional cases with reasons to be specified by the committee members. At this point members opined that the spirit of recognition to the work and encouragement be maintained while awarding the grades. The grades awarded by the committee will be final and will be binding on the students and the PBI guides. Also, it was suggested by the senate that the PBI reports would be archived.

The academic load formula submitted by the Committee was discussed in details. Member opined that the document be termed as self-regulatory guidelines and should not be taken up later as a factor during the faculty assessment. These guidelines may be taken as reference in measuring how much a faculty is loaded before assigning him/her a new administrative

responsibility. One of the member suggested that core courses may be given more weightage in terms of student interaction. The Senate agreed to this proposal and approved the guidelines after discussion. It was also suggested to review the guidelines from time to time as and when new inputs are received.

The agenda was deferred to the next SENATE meeting. Some members showed their concern and requested that the report must be submitted much before the next session starts. It was decided that the convener be asked to expedite the matter and submit the report of the committee within a month and before the next Senate meeting.

Senate/2011-12/1.10	Reduction of load for 1 <sup>st</sup> semester undergraduate students.

The matter was discussed in details. Members suggested various models to make the programme more effective and students friendly. One model was based on reduction of course contents and then rescheduling the courses at later stages. The other suggestion was to make the courses modular and with floating credits with well-defined pre requisites. Students should be allowed to opt for courses from the beginning of their programme so that they determine by what time to complete their graduation with an upper limit on number of years as specified in the Senate manual (presently six years). Some members suggested holding of extra classes in summer/ winter session to help academically deficient students.

It was decided that a concrete proposal be presented in the next meeting of the Senate to discuss this matter further for a decision. Members suggested submission of two different models giving due consideration to the repercussions due to load reduction/ redistribution.

Senate/2011-12/1.11	Ratification of the approval accorded by the Chairperson, Senate.

The Coordinator Academic Affairs informed the members about one note of dissent communicated by Dr. Bhupendra Gupta on the approval accorded by the Chairperson, Senate listed below as item no. 17. The Coordinator Academic Affairs informed the members that the course NS 505: Stochastic Processes was not running in the semester and no classes were held for that course. Hence he took approval from the Chairperson, Senate to drop /withdraw the

course. Dr. Bhupendra Gupta also agreed that no classes were held for the course NS 505 – Stochastic Processes. After deliberations, it was concluded that due to some communication gap and deficiencies present in the evolving system of academic section, the course was floated erroneously.

At this point of time, some of the members raised queries on the numbering system of the courses. COAA informed the members that numbering system was defined for the old curriculum and has been changed now for the revised curriculum. He also informed the Senate that some times the formal course proposals are submitted very late by the faculty and hence temporary numbers are allotted to the courses to reflect them in the time table. Once a formal course proposal is submitted and approved, the number is allotted to the course. Members expressed their concern on this issue and it was resolved that the course proposals should be submitted at least a semester before the commencement of the course. The last date for submission of a course proposal in each semester was decided as fifteen days before the commencement of the end semester examination.

It was decided to introduce “Academic Registration” in the first week of the last month of each semester (i.e. first week of November and first week of April) for the courses to be offered in the subsequent semester ( even semester and odd semester respectively). This academic registration has to be reflected in the academic calendar and accordingly, it was decided to modify the Academic Calendar for the year 2012 also so that the dates of academic registration are reflected properly.

The Senate approved the changes proposed for the present 2010 batch.


**Senate/2011-12/1.12.3** Alumni Association
