The Senate expressed its satisfaction over the performance of students and especially noted that there were two students qualifying for Chairman's gold medal. The rules in case of such ties were deliberated and it was suggested that for Chairman's Gold medal only the final CPI should be the sole criterion as it is awarded for best academic performance. It was also opined that there should not be any further conditions on the decision for a gold medal if there is a tie among two candidates in their CPI.

Some members also suggested having a review on the conditions for eligibility to apply for medals/prizes in case of PG students since in most of the cases the thesis work is not completed by the time applications are invited. In view of the above point, it was decided to keep all the decisions for award of gold medals to PG students on hold until their theses are submitted. The Chairperson, Senate was authorized to take a decision on the recommendations of the committee at a later stage for each such case, when the degree requirement of the student is completed.

After deliberations it was felt that there is a need to make amendments in the SPACS manual. It was suggested to bring the proposal for amendments in the next meeting of the Senate.

Senate approved the names of students listed above for award of medals /prizes written against their names to the Board of Governors under the condition that there are no cases of indiscipline against the recommended students. Further the Coordinator, SPACS informed the members that reports and recommendations of two of the committees were awaited. The Senate authorized the Chairperson, Senate to take a decision on recommendations to be made by the committees.

Senate/2010-11/3.05 Reports of SACS, LCS and Students' counseling services

Reports of SACS and LCS were presented in the meeting. SACS specified that the period was peaceful. Senate requested Convener SACS to present SACS report for the full semester in its next meeting. Convener LCS presented a report on the library services and the developments made during the last year. He informed the members about the number of journal being subscribed and books purchased during the year. No report was submitted on Students' counseling services.

The Senate deliberated on the proposal and concluded that the proposal requires further modifications and refinements based on the suggestions given by the members and invitees present. Convener of the Committee was asked to submit the modified proposal within fifteen days so that the same could be circulated to members for a decision through circulation.

It is decided that the Internship Board (IB) shall be responsible for overall general administration related to the Project Based Internship. The Board will be responsible for keeping contacts with the companies, industries and R&D organizations to arrange paid/ self financed internships for



students, in consultation with the placement cell. The Board will also be responsible for the classification of projects and constitution of various internship evaluation boards for the PBI based on the classification. Further, IB will also be responsible for approving the list of companies /industries / R&D organization where a student can pursue his PBI.

Next, The Coordinator, Academic Affairs presented the calendar for PBI and the basket of marks for evaluation of PBI. The Senate approved the same after discussions (Please refer to Senate/2010-11/3/Annexure V)

Senate/2010-11/3.10.1 Consideration of Candidature of three M.Tech. (ECE) Students

Three M.Tech students, Mr. Manpuram Mahto, Mr. Pankaj Singh Yadav and Mr. Agya Ram Verma were erroneously admitted in M.Tech (ECE) Programme in the winter semester admission period during December, 2010. The three students were having valid GATE score but were not qualified for admission (under OBC category) as regular students with Institute assistantship as per the guidelines of PG Manual of the Institute. By oversight, the students' GATE score cards were not properly verified by the Institute staff. However, they had cleared admission test and interview and were admitted. The students inadvertently continued receiving the institute assistantship (IA) of Rs. 8000/- pm in their first semester.

Later it was brought to the notice of the authorities that students do not have qualifying marks to be eligible for IA. Institute inquired the matter and asked the students for clarification. The students submitted their appeal and made requests to allow them to continue their M.Tech (ECE) programme without assistantship. They have also stated that they are ready to deposit the entire IA amount received by them till date.

In view of the performance of the students in the first semester the Senate decided to continue their programme as special cases without Institute assistantship under the category – self supported: special case. The Senate also recommended recovering the amount of IA received by them till date. It is requested to ratify the decision of the Senate and to approve the recovery of the IA amount from the three students (names mentioned above). Performance of the students in first semester is shown against their names.

Senate/2010-11/3.10.2 Seat Matrix of UG and PG programme

The Coordinator, Academic Affairs informed the members that the Institute does not have any record of approval of the seat matrix by the Board for some of the previous academic years. The Coordinator, Academic Affairs also proposed to have no increase in intake for the next two years keeping in view the acute shortage of civil infrastructure. The seat matrices presented by the Coordinator, Academic Affairs were approved for recommendation to the Board for post facto approval of the seat matrices of the academic years 2005-06 to 2010-11 and for approval of the seat matrices of the academic years 2011-12 and 2012-13. Senate/2010-11/3.10.3 Weightage of EMF (Elective in Modular Form)

It was informed by the Coordinator Academic Affairs that the credits allocated to courses under the label 'Electives in Modular Form' (EMF) have resulted in anomalies in the credit system. Each EMF is of 12-14 lectures and carries 2 credits. However, a student is required to register in three EMFs (6 credits) in place of a full course of 4 credits. Further some of the members expressed their concern on the students' feedback about EMFs since in many cases EMFs offered by the external faculty are covered in 3-4 days and students do not get sufficient time to assimilate and grasp the concepts taught in the course. Senate deliberated on the mode of implementation of EMFs and opined that better ways should be evolved to make EMFs more effective in future.



After deliberations the Senate decided to improve the structure of EMFs and their credit allocation. Accordingly, It was decided to have an EMF of 10 lectures duration only and 1 credit each excluding the examination/assessment duration. A student can register in four EMFs to replace a course in the same semester. Further, the Senate members suggested to have the minimum duration of the five days for delivering lectures under EMFs.

Senate/2010-11/3.10.4 Financial support to UG and PG students for attending reputed national/international conferences

In order to promote research and development in the Institute, the Institute faculty had recommended that some incentives be given to the students pursuing research in the Institute. Accordingly it was proposed that financial support be provided to the students if their research papers are accepted for oral presentation in reputed national /international conferences. After deliberations, the Senate unanimously recommended following to the Board.

- i) A onetime assistance throughout the programme upto Rs. 50,000/- on reimbursable basis for post graduate students (including Ph.D. students). This would include reimbursement of expenses incurred on payment of registration fee, local travel, air/rail fare, lodging and boarding as per actual. A student will get financial assistance only on the recommendation of the Postgraduate Committee of the Senate and on the approval of the Director.
- ii) A onetime assistance throughout the programme upto Rs. 35,000/- on reimbursable basis for undergraduate students. This would include reimbursement of expenses incurred on payment of registration fee, local travel, air/rail fare lodging and boarding as per actual. A student will get financial assistance only on the recommendation of the Undergraduate Committee of the Senate and on the approval of the Director.

Senate/2010-11/3.10.5 Course Content for the Course on Materials & Manufacturing Processes

Course content for course on Materials & Manufacturing Processes was placed before the Senate members. Senate members suggested minor modifications in the contents and authorized Chairperson, Senate to approve it later.
