This has referenced to your letter No. IIITDMJ/Dir/2014/08-1307 dated 25-08-2014. The LCS meeting was called on dated 24-09-2014 and discussed point (1 and 2) and also the internal budget allocation for the financial year (2014-15).

Letter Point No. 1: There should be an upper limit on the total overdue charge on an issued item, if it is not returned on time. For reference/rare books overdue charges per day may be higher than the rate for normal text and other such books.

Letter Point No. 2 Provision of online renewal should be made at least once.

Recommendations of LCS Members are: (Minutes of meeting attached herewith)

- a) Library sends regular alert message every fortnightly to all users for return/re-issue.
- b) Overdue charges will be applied after the due date of Rs. 1.00/per day/per book applicable to all library users.
- c) Library will send two individual reminders through email, one before overdue date and second will be sent after one month of overdue date. Third reminder will be sent through letter after 15 days of second reminder. If the library user will not return/reissue the issued book, then a penalty of Rs 5000/- per book will be applied to library user for late submission/ such ignorance level irrespective the overdues plus book cost. Individual reminders will be only sent when new library software is purchased as this facility is not available in current software.

Discussions and Decision as per agenda items

 Discussion on Director Letter: The LCS members scrutinized the letter No. IIITDMJ/Dir/2014/08-1308 dated 25-08-2014 issued by the Director, regarding library overdue charges (letter point No.1 and 2) only discussed. The following points are:

Letter Point No. 1: There should be an upper limit on the total overdue charge on an issued item, if it is not returned on time. For reference/rare books overdue charges per day may be higher than the rate for normal text and other such books.

Letter Point No. 2 Provision of online renewal should be made at least once.

The LCS members are decided:



- a) Library sends regular alert message every fortnightly to all users for return/re-issue.
- b) Overdue charges will be applied after the due date at rate of Rs. 1.00/per day/per book applicable to all library users.
- c) Library will send two individual reminders through email, one before overdue date and second will be sent after one month of overdue date. Third reminder will be sent through letter after 15 days of second reminder. If the library user will not return/reissue the issued book, then a penalty of Rs 5000 per book will be applied to library user for late submission/ such ignorance level irrespective the overdues plus book cost. Individual reminders will be only sent when new library software is purchased as this facility is not available in current software.
