Applications are invited from highly motivated and research-oriented applicants for admission to PhD Program in the following disciplines as per the below mentioned categories of admission and time schedule.

- 2. Electronics & Communication Engineering (ECE)
- 3. Mechanical Engineering (ME)
- 4. Smart Manufacturing (SM)
- 5. Design (DS)
- 6. Natural Sciences-Physics (NSP)
- 7. Natural Sciences-Mathematics (NSM)
- 8. Liberal Arts-English (LAE)

Applicants having qualified GATE/ National Level Exams (CEED/ UGC (JRF/NET)/ CSIR/other equivalent) are preferred for admissions, however, candidates who have not qualified GATE/CEED/NET may also apply for admissions.

#### **Eligibility for Admissions**

A minimum of 60 percent marks OR a CPI/CGPA of 6.0 (on the scale of 10.00) shall be required at the Master's level qualifying examination (M.Tech./M.E./M.Des.) as the specified minimum for admission in a Ph.D. programme. Eligibility criteria for each discipline is specified below

- i. GATE/CEED/NET is not compulsory.
- ii. Applicants having qualified GATE/ UGC(NET/JRF) / CSIR/ CEED/ other equivalent will have to appear for the interview only.
- iii. Applicants who have not qualified in GATE/CEED/NET will have to appear for a written exam to be conducted at the Institute level, and only shortlisted applicants through the written test will be interviewed and considered for admission.
- iv. Meritorious applicants of undergraduate program (B.E./B.Tech.) currently in their final year in any of the CFTIs with a minimum CPI of at least 8.0 or equivalent (on a scale of 10) are eligible to apply for direct admission in Ph.D. program after B.E./B.Tech.
- v. Interested candidate with degrees in other disciplines such as Medicine/ Agriculture/ Dental/ Ayurvedic/ Sciences etc may be considered for admission, as a special case.

### Financial Support (applicable for IA category students)

- i. Institute Assistantship will be provided to all selected candidates under IA category.
- ii. Support up to Rs 50,000/- is provided for the purchase of components/ equipments towards project-related work.
- iii. Support of up to Rs. 50,000/- and Rs 10,000/- is provided towards support to attend an International Level Conference for presenting the research work outside India and within India, respectively.

### **Application Procedure**

- i. Students can apply only through the online application portal. There is no provision for offline submission of application forms.
- ii. In case a candidate wishes to apply for more than one discipline, a separate application must be submitted for each discipline.
- iii. After successful submission of the application form, please save the application form. You need to furnish hard copy of the application form and self-attested copies of all the relevant documents at the time of the interview.
- iv. Incomplete applications will be rejected.
- v. The application fee for Ph.D. program is as follows:

• Rs.300/-: For SC/ST/PwD

• Rs.500/-: For GEN/OBC/EWS

#### **Selection Procedure**

- For applicants having qualified GATE/ National Level Exams (CEED/ UGC (JRF/NET)/ CSIR/other equivalent) - Selection would be through the interview process by the discipline level committee.
- 2. For candidates not qualified in GATE/CEED/NET and wish to apply for IA category
  - i. A written exam of three-hour duration (on GATE exam pattern) with two parts:
    - b. Part A will be common for all applicants consists of questions based on the quantitative and logical aptitude
    - c. Part B will consist of technical questions related to the respective discipline.
  - ii. Shortlisted applicants will have to appear for through the interview process by the discipline level committee.

- 3. Candidates appearing in the final exams and expected to complete their program may also apply for admissions. They will be provisionally admitted in the programme.
