Details terms & conditions for applicant

Generals

- 1. The received expression of interest (EOI) after the due date and time will not be considered.
- 2. Incomplete application form or wrong information mentioned on prescribed documents by the vendors/suppliers will be rejected.
- 3. Qualified vendor/supplier would be required to sign agreement on terms and conditions with the Institute on judicial stamp papers of Rs 50.00 (Rupees Fifty Only).
- 4. Qualified vendor/supplier upon receipt of confirmed order shall process Institutional subscription. Payment shall be made on satisfied delivery of the magazines.
- 5. Initial contract will be for one year. It may be extended further for another year after satisfactory services.
- 6. The competent authority of PDPM-IIITDM Jabalpur has right to discontinue contract in any time if any discrepancy found.

Terms & conditions for supplying of magazines:

- 1. Institute will place order through e-mail along with hard copy. After receiving the order vendor/suppliers should be supply the magazines according to the frequency within 15 days.
- 2. Magazines to be supplied for the period April 2017 to March 2018, supply of the magazine should commence from the latest issue of the month. Volume.
- 3. Other material like CD/online version are available which the magazine should be provided free of cost by the vendor/supplier.
- 4. The charge of any consignee and mode of dispatch should be sent to the library by speed post, parcel /registered parcel/courier/will be prone by the hand.
- 5. Every supply should be accompanied by a delivery challan, clearly bearing the details of the title in the supply, their quantity and price. Freight on road (FOR) PDPM-IIITDM Jabalpur.

Pricing /Invoicing:

- 1. Vendor/suppliers shall certify that the prices quoted supply to magazine in the Invoice(s). However printed price of the magazine.
- 2. Conversion rate of foreign currency to Indian currency will be obtained either through (a) website of the reserve bank of India or (b) Economic times edition of the day in concern or (c) any National bank where the supplier maintains his/her account and on which the bill has been raised.

3. Invoice should be raised in favour of the Registrar, PDPM-IIITDM Jabalpur.

- 4. Pre-receipted invoices are to be submitted in triplicate (3 copies).
- 5. A revenue stamp should be affixed on the original invoice and should be signed by authorized vendor/supplier.
- 6. The prices in the invoice should be indicated in original currencies, Indian Rupees with the currency conversion rate and enclosed conversion rate proof.
- 7. The vendor/supplier has to specify clearly the flat discount rate to be given for the supply of magazine keeping in view the total order value. Such discount will be subject to deduction from the bill amount itself.
- 8. No interest would be payable on amount paid by the subscription agent to the publisher on account of delay in payment by the institute.

Penalty:

1. In case of delay in supply magazines penalty @ 1% per week and so on will be imposed.

- 2. In case of magazines that are not supplied, a certificate of non-availability of those magazines from the publisher should be furnished within the due date of supply. Otherwise vendor/supplier will be penalized based on point 01.
- 3. In very specific cases of delay in supplying of magazines within the stipulated periods, and the delay is justified due to valid reasons with adequate proof (e.g communications from publisher). The vendor/supplier will be responsible for seeking the permission from the Librarian/person-in-charge.

- 2. In case of breach of any terms of agreement or unsatisfactory working on the part of the supplier.

- 2. For any dispute, arbitration will be jurisdiction court only Jabalpur.
