

Minutes of Pre-Bid Meeting (Hiring of Bus Services)

Date: 06-03-2020

Venue: Conference Hall (Admin Block)

Time: 03.00PM

The pre-bid meeting was held on 06th March 2020. During the meeting M/s Om Traders Jabalpur submitted following observation/comments, same has been sent via email. [Copy attached as Annex.1]

Committee members discussed the observations/comments and recommend followings:

Tender Clause No. 1 (ii): "During the contract period, the Institute can use buses for any purpose. The buses should be made available 24 Hrs x 7days."

Clarification: It is clarified that at present the buses are required as per the time table/bus schedule given in tender document. However the time table/schedule may change. During the year Institute may demand buses **beyond/other than the regular schedule** for Institute's function/event etc. Such requirement will be intimated to service provider before 24Hours.

Tender Clause 5 a (ii): "Copy of Registration of Buses at least 02 eligible buses for 52 Seating capacity, (Capacity as per RTO registration and make of Bus)"


During Pre-bid meeting on 6th March,2020 it is informed by M/s Om traders that due to the provision of double-door in the buses, RTO is passing 47+2 Seater buses, which accommodate 52 students. Hence, Registration of 47+2 may be considered.


Clarification: It is clarified that seating capacity should be 52 ie 50+2 which may be verified only with the Registration Certificate (RC). However if any bidder has submitted RC with 47+2 seating then he need to produce an affidavit (on stamp of Rs. 100/-) that RC of 52 Seating (50+2) is not being issued by RTO due to double door provision in buses.
