- (B) PAN, GST & Company Incorporation Certificate for firm etc. and Adhaar of representative

Along with Demand Draft as EMD and Second inner cover containing: Price bid should be sealed properly. The two cover should be put in another Outer Cover and may be dropped in the Tender Box of General Administration Section kept at Administrative Block of PDPM IIITDM Jabalpur, Dumna Airport Road, PO Khamaria, Jabalpur-482005. - 2. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this Department/Institute. The condition of the vehicles can be inspected physically between 16-03-2020 to 19-03-2020 During 3:00PM to 4.00PM at PDPM IIITDM Jabalpur, Dumna Airport Road, PO Khamaria, Jabalpur-482005.
- 3. The quotation should be accompanied by earnest money for Rs.5,000/- for each vehicle. The earnest money should be deposited by Demand Draft in favour of PDPM IIITDM Jabalpur. The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest/successful tenderer is accepted by the competent authority of this Institute fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. The EMD shall be forfeited if the bidder fails to transfer the vehicle ownership within 45 days from the award of the tender.
- 4. EMD amount is payable ONLY by means of Demand Draft in favour of PDPM IIITDM Jabalpur. (Payment by Cheque/Cash shall not be accepted). Offers received without EMD amount shall not be considered at all by the Institute.
