### **General Terms and Conditions**

- Bidders should submit the EoI in a sealed envelope to "Registrar, PDPM IIITDM Jabalpur".
   Envelope should be superscribed as "<u>EoI for Empanelment of Laundry Services Providers</u> <u>at IIITDM Jabalpur"</u>. Bids can be submitted in person/through post/through courier.

If the empaneled bidder does not vacate the allotted space after the expiry of the contract agreement period or after one month of notice period of termination of agreement, the institute has right to vacate the space, and acquire it.

If the Firm/ Agency/Company/Proprietor indulge in carrying out any unapproved activities, the PDPM IIITDM Jabalpur is at liberty to cancel the contract agreement of the Firm/ Agency/Company/Proprietor/individual with immediate effect.
- 17. The empaneled bidder shall maintain and develop their allotted space or shop without causing any damage to its surroundings during the period of the contract agreement. The institute will not provide any furniture and fixtures for the allotted space.
