  - d) A certificate from the OEM (Original Equipment Manufacturer) confirming that the bidder is an authorized dealer/distributor for the product or is authorized to submit a quotation for the said software in response to this invitation.
- 2) The rates quoted should be **FOR Destination (i.e., delivered via electronic means or license transfer)** inclusive of all applicable taxes/statutory levies (GST or any other applicable central/state government taxes). No additional charges shall be entertained by IIITDM Jabalpur.
- 3) The software license shall come with a **valid support contract** for the period mentioned in the specifications (refer Annexure-I).
- 4) The supplier must ensure **technical support** (email/phone/online) for installation, activation, and operation issues for a **minimum of 2 years** from the date of installation.
- 5) License keys and installation files/access credentials must be **delivered within 15 working days** from the date of issue of the work order.
- 6) Sealed quotation should reach on or before **3.00PM, 21/08/2025**, to the **AR (Purchase), PDPM-IIITDM Jabalpur, Dumna Airport Road, Mehgawan, Jabalpur-482005**.
