2.01 Gym

2.01.01 The students demanded a camera to be installed in the boys' gym to avoid any cases of theft or conflicts amongst students. The Warden assured that this matter will be taken up at a later time period.

2.01.02 They also demanded that the residents of other hostels should not use the Hall 1 gym. The Gym Committee of boys was told to make a proposal regarding the same to be discussed amongst HEC before communicating to Dean Students for necessary actions.

2.01.03 The Gym Committee (B) was told to make a proposal regarding the maintenance of the boys' Gym.

2.02 Hostel Maintenance and Welfare issues

2.02.01 The students demanded the use of naphthalene balls in the washroom basins to avoid insects.

2.02.02 There are various issues related to plumbing in the hostel. The Warden assured that the plumbing material has been bought and the work will begin soon.

2.02.03 Water seepage issues in the hostel were reported. The Warden informed that while most rooms have been rectified, some rooms are beyond repair, where a major work needs to be carried out (verified by IWD). Any specific case which can be rectified by the plumber of the hostel shall be addressed, other issues need to be communicated to IWD as and when reported.

2.02.04 The students also complained about the cleaning of washing machines. The Warden informed that if the machines are in the AMC period, then the same will be carried out after notifying competent authority.

2.02.05 The Warden reminded that feeding the animals in the hostel premises will attract a fine of Rs.500.

2.02.06 The HEC members were told to verify the cleaning material next time as they had doubts.

2.02.07 The girl students complained about the toppling of the dustbin in washrooms. The Assistant Warden assured them that the college is getting incinerators soon.

2.02.08 The HEC asked for a separate ID for students of Hall 1. The Warden said that it can not be possible due to the dynamicity in the residents.

2.02.09 The HEC representatives of block D, E and F were asked to put up a notification for room change. This involved shifting of PhD students of E and F block to D block. And shifting of BTech students residing in D block to E and F block.

2.02.10 The Warden clarified that no student is allowed to access the computer system in the Warden's office.

2.03 Canteen

2.03.01 It was decided that only the HEC members could enter the canteen kitchen area. Other students are refrained from doing so.
