2.05.02 The student body will be mailed the link of the intranet webpage after the minutes have been uploaded.

**2.06 Logo for Student Gymkhana to be designed**

2.06.01 A mail had been drafted to the students of design discipline inviting entries for a logo for the Student Gymkhana, IIITDM, Jabalpur.

2.06.02 Once the logo is finalised, it will be incorporated in certificates to be distributed to the office bearers of Student Gymkhana for the year 2016-17.

**2.07 Any other matter related to the student body**

2.07.01 It was proposed that printing facility should be available in every hall. So as to avoid exploitation of printing facility, it could be provided on a paid basis or the number of copies can be limited. A register can be maintained by the caretaker for the same.

2.07.02 The irregularity of access of the ATM was pointed out. The Senate proposed that the direct route from within college should be made accessible and not be shut simply at the will of the policemen or guards.

2.07.03 It was also proposed that at least one canteen should be accessible to all students 24X7.
